





#### **Benefits**


Real time Process Visibility

Dynamic linkage to controls

Efficiency – update 1 location instead of 2-5 locations

Move from managing documents to managing process data

Increased productivity and collaboration between business and technology



## Process Excellence

Metrics	Use metrics to identify opportunities, show benefits of CI, how well is your product working
Change Mgmt.	Manage changes, reduce risk of error, improve change mgmt. communication
Continuous Improvement	Eliminate, Simplify, Standardize and Automate processes
Process Management	Documenting process is the basis for all other Process Excellence activities

#### **Best Practices**

┎┍╭

Start at the bottom (many team flows) and link your way up to the Product level



Have agreed process development guidelines Have agreed library structure/hierarchy spaces (we use Product/Product family)



Use separate spaces for processes that are 'in draft' vs 'in Production'



Experiment and continuously improve



Make the process flows useful to the team, not just for Risk or Audit



Use the data captured in the BWL metadata for process monitoring, reporting, metrics, opportunity tracking (problems)
